The purpose of the **PUBLIC HEARINGS** is to receive opinions from the general public and to answer questions on the proposed tax change and budget **PRIOR TO TAKING FINAL ACTION**. Each Taxing Authority may **AMEND OR ALTER** its proposals at the hearing.

EXPLANATION OF 'TAXING AUTHORITY TAX INFORMATION' SECTION
<p><b>COLUMN 1 - "PRIOR TAXABLE VALUE"</b> This column shows the prior assessed value less all applicable exemptions used in the calculation of taxes for that specific taxing authority.</p>
<p><b>COLUMNS 2 &amp; 3 - "YOUR FINAL TAX RATE AND TAXES LAST YEAR"</b> These columns show the tax rate and taxes that applied last year to your property. These amounts were based on budgets adopted last year and your property's previous taxable value.</p>
<p><b>COLUMN 4 - "CURRENT TAXABLE VALUE"</b> This column shows the current assessed value less all applicable exemptions used in the calculation of taxes for that specific taxing authority. Various taxable values in this column may indicate the impact of Limited Income Senior or the Additional Homestead exemption. Current year taxable values are as of January 1, 2023.</p>
<p><b>COLUMNS 5 &amp; 6 - "YOUR TAX RATE AND TAXES IF NO BUDGET CHANGE IS MADE"</b> These columns show what your tax rate and taxes will be IF EACH TAXING AUTHORITY DOES NOT CHANGE ITS PROPERTY TAX LEVY. These amounts are based on last year's budgets and your current assessment.</p>
<p><b>COLUMNS 7 &amp; 8 - "YOUR TAX RATE AND TAXES IF PROPOSED BUDGET CHANGE IS MADE"</b> These columns show what your tax rate and taxes will be this year under the BUDGET ACTUALLY PROPOSED by each taxing authority. The proposal is NOT final and may be amended at the public hearings shown at the top of this notice. The difference between columns 6 and 8 is the tax change proposed by each local taxing authority and is NOT the result of higher assessments.</p>

EXPLANATION OF 'PROPERTY APPRAISER VALUE INFORMATION' SECTION
<p><b>MARKET (JUST) VALUE</b> - The most probable sale price for a property in a competitive, open market involving a willing buyer and a willing seller.</p>
<p><b>ASSESSED VALUE</b> - The value of your property after any "assessment reductions" have been applied. This value may also reflect an agricultural classification. If "assessment reductions" are applied or an agricultural classification is granted, the assessed value will be different for School versus Non-School taxing authorities and for the purpose of calculating tax levies.</p>
<p><b>APPLIED ASSESSMENT REDUCTION</b> - Properties can receive an assessment reduction for a number of reasons including the Save Our Homes Benefit and the 10% non-homestead property assessment limitation. Agricultural Classification is not an assessment reduction, it is an assessment determined per Florida Statute 193.461.</p>
<p><b>EXEMPTIONS</b> - Any exemption that impacts your property is listed in this section along with its corresponding exemption value. Specific dollar or percentage reductions in assessed value may be applicable to a property based upon certain qualifications of the property or property owner. In some cases, an exemption's value may vary depending on the taxing authority. The tax impact of an exemption value may also vary for the same taxing authority, depending on the levy. (i.e., operating millage vs. debt service millage).</p>
<p><b>TAXABLE VALUE</b> - Taxable value is the value used to calculate the tax due on your property. Taxable value is the assessed value minus the value of your exemptions.</p>
